HB 3449 - Geolocation Privacy Protection Act, passed the House as

amended by H. A. #2 with a vote of 69 Yes, 42 No, 1 Present. Following is the link for the Engrossed version which now goes to the Senate. Note the exemption for detectives.

Again, I point out that it remains a controversial piece of Legislation. We will monitor it.

HB 3464 - Amends the Private Detective, Private Alarm, Private Security, Fingerprint Vendor, and Locksmith Act of 2004. In provisions concerning qualifications for licensure as a private security contractor.

HB 3464 passed the House, as amended by H.A. #1, by a vote of 105 Yes, 0 No, 1 Present. Following is the link for the Engrossed version which now goes to the Senate.
