From our Lobbyist

Legislative Report from John Carr:

John and Alice continue to make strides on ADSAI's 2018 legislative agenda.

On Wednesday, April 11, the Senate Judiciary Committee unanimously passed Senate Bill 2642 (Munoz) on a vote of 11-0-0. That bill will now go before the Illinois Senate for a floor vote. SB 2642 deletes the requirement (under State law) for retired police officers from having to obtain a Firearm Control Card (FCC) to be a licensed private detective if they are already in good standing under federal law (The LEOSA Act of 2004). We hope SB 2642 will make it

easier for our members to quickly hire retired police officers into the profession.

In addition, our lobbyists successfully 'killed' SB 3146, a hostile amendment to our Act that would have deleted our members' ability to file an injunction against unlicensed individuals and companies that hold themselves out to be licensed guards and detectives.

While the lobbying team was unable to move SB 2462--a bill creating continuing education (CE) standards for private detectives--Representative Brian Stewart, himself a retired police officer and licensed private detective, has pledged to assist us on strategies to implement CE requirements by administrative rule. John and Alice will be meeting with Rep. Stewart during the next few weeks to discuss ways in which Illinois' Department of Financial and Professional Regulation can implement our CE initiative.


